Bro. Jos. K Lane made explanation, the things

if which Benson had accused his sister, which

he had every reason ti believe false, so exasperat-
ed

him that he felt just like caneing Benson

and he still felt the same way if Benson

did not take that back, yet he was willing to

leave it with the High Council, and abide their

decission..

Jerome M. Benson was bro't up, after some

explanatory remarks the clerk read the charge

Councillor J.M. Benson..
