taken sick- after that I knew nothing different .I had what supported

my family and some more, and I knew nothing different untill he

came into to he mill and forcibly drove me out of
the mill

there was some 150 bus, joint stock wheat in the
mill at that

time= Bro Cooley said the statement of Bro Gould
relative to his being up in the winter was correct
we talked about

building a mill & he spake of this place= I sold out
on

Shartion gathered up my teams provisions &c and
came

up here I also had about \$100. in money- I spent
what I

had as Bro. Brigham told me- I let him have my
teams

and inent to work to build a mill, to sell out, and to

take Bro. Gould with me to the Valley- We have
not

been able to sell yet=went to work & built the mills

I spent my property without reference to the
amounts

invested by either- he has no right yo claim the
half

of the improvement, s he has not invested the half
