Pres. Hyde asked him if he recolected telling

one, that it might be tall business if the Authorities

here meddled it, for there were some tall men con-  
cer-

ned in it.. Witness said he did not..

William D. Huntington was called upon..

W. D. Huntington testified, that Joseph A. Kelting

asked him if he knew anything of the trial on  
bogus matters that was fending against Mr. Moloh-  
land  
and said he tho't they had better be careful for he  
tho't there were some tall men concerned in  
it,, said Mr. Kelting told him this as rumor..
