that you will not suffer a man to threaten a whole

town upon your credit without separating him from

your fellowship. Our brethren here are doing generally, the best

they can to help themselves by their labor and industry.

unprovoked outbreaks of such thoughtless and unprincipled

men. His is given you in truck, as it has been given

to me by witnesses which the church is lawfully bound

to respect, honor, respect and act upon..
